Dear Secretary Duffy,

The undersigned passenger rights advocacy organizations are deeply disappointed with DOT's decision¹ to withdraw the Airline Passenger Rights Advanced Notice of Proposed Rulemaking (ANPRM).² The long overdue ANPRM was intended to bring the U.S. air travel sector in line with basic consumer protections found in other jurisdictions which already protect billions of international travelers.

The proposed passenger rights are simple policies designed to keep the American travel sector competitive with others around the globe. The ANPRM also fits squarely within your stated priorities of tailoring transportation policy to protecting American families. Controllable flight disruptions can cost traveling families thousands of dollars, with just one mother losing \$7,500 during last year's Crowdstrike outage.³

The hasty withdrawal of the ANPRM is a reversal of common-sense America First policies and a betrayal of traveling families. The withdrawal also signals that the Department appears to be less interested in curtailing significant flight disruptions, which have increased 4x in the past 30 years.⁴ Not insignificantly, the withdrawal may contravene federal law that explicitly directs the Department to protect the public interest, prohibit unfair and deceptive practices, and require airlines to establish consumer protections for controllable flight disruptions.⁵
